## TERMS AND CONDITIONS

1. To be eligible for the LED Light Rebate you must arrange for your builder to provide LED lighting to over 90% of your home in accordance with the Allara Development and Design Guidelines as part of your building contract.
2. You must arrange for the builder or installer to provide signed written notice on their company letterhead advising of the installation of the LED lighting in your home.
3. The notification that LED lighting has been installed must accompany this completed voucher.
4. To be eligible for the Smart Thermostat or Air Conditioning Rebate you must arrange for either your builder or a suitably qualified installer to install either:
  - a) a smart thermostat (Nest learning thermostat or Honeywell Lyric); or
  - b) an energy efficient air conditioning unit (with COP > 3.20 and ERR > 3.00).
5. You must arrange for the builder or installer to provide signed written notice on their company letterhead advising of the completion of the installation of the smart thermostat or energy efficient air conditioning unit in your home.
6. The builder or installer notification that the smart thermostat, energy efficient air conditioning unit, energy monitors or smart meters has been installed must accompany this completed voucher.
7. The developer will pay the Allara Energy Efficiency Rebate, up to a maximum of \$1216, to you within thirty (30) days of receiving the completed voucher.
8. This voucher is not transferable or assignable to any other party and may only be claimed by the buyer named in the Contract.
9. If the Allara Energy Efficiency Rebate is not claimed or redeemed within thirty-six (36) months of the settlement date of your lot, this voucher will expire worthless. The developer will have no further obligation or liability to provide or pay for the Allara Energy Efficiency Rebate.

The developer shall not be liable to you under any circumstances for the acts or omissions of the builder or installer responsible for the installation of the LED lighting, smart thermostat, energy monitors or air conditioning unit in your home, including for any delay in completing the installation which may invalidate this voucher.
