1. **Application of Terms and Conditions**

- Information on how to enter and Prize details form part of these terms and conditions. 1.1

2. Who can enter the Competition

3. **How to enter the Competition**

- To enter the Florence Builder Competition, each entrant must submit a Contract of Sale for an Eligible Lot to the Promoter during the Promotion Period.
- 3.2 Entries are deemed to be received by the Promoter:
 - if delivered, at the time of delivery;
 - b) if sent by post, at 9.00am on the date on which it is received; and
 - if sent by facsimile or email transmission, at the time and date on which the facsimile or email transmission is sent.
- 3.3 The Promoter reserves the right, at any time, to request verification of the name, identity, ABN or any other information relevant to participation in the Florence Builder Competition of all entrants. The Promoter reserves the right to disqualify any entrant who provides false information or fails to provide information that is reasonably requested by the Promoter.
- 3.4 The Promoter reserves the right, in its sole discretion, to refuse to accept entries which are incomplete, indecipherable, offensive, do not comply with these terms and conditions or any applicable laws or regulations.
- 3.5 The Promoter reserves the right, in its sole discretion, to disqualify any entrant who has breached any of these terms and conditions, has engaged in unlawful or improper conduct or otherwise acts to cheat or undermine the fairness of the Florence Builder Competition.

4. **Prizes**

- 4.3 If a Prize is unavailable for reasons beyond the Promoter's control, the Promoter reserves the right to substitute the Prize with a prize of equal or greater monetary value. This right is subject to any applicable legislation, regulations or directions from any regulatory authority.
- All taxes (excluding GST, if any) which may be payable as a consequence of receiving a 4.4 Prize are the sole responsibility of each winner. Any other expenses involved in redeeming the prizes are the winner's responsibility.
- 4.5 A winner's use of a Prize is entirely at their own risk. 5. How the Winners are determined

- 5.2 The Promoter's decision will be final and binding and no correspondence with entrants or any other person will be entered into.

6. Notification and claiming the Prize

- The Promoter will notify each winner and provide them with instructions on how to claim their Prize. It is the responsibility of each winner to comply with the Promoter's instructions.
