Provisions

This Local Development Plan (LDP) applies to Lots 60, 90-98, 104-109, 156 & 161 within the Clementine Estate - Local Structure Plan area.

The R-Code for each lot is as per the prevailing Density Sites Plan.

The requirements of the R-Codes and/or R-MD Codes are varied as shown on the plan and below.

Minor variations to the requirements of the R-Codes, Local Planning Policy POL-LP-11, R-MD Codes and this LDP may be approved by the City of Swan.

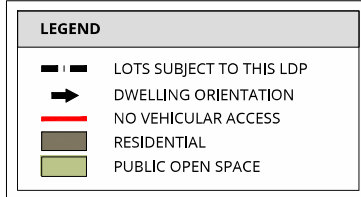
R60 Density Code

- Unless otherwise defined on this LDP, all development shall be in accordance with the City of Swan Local Planning Scheme No. 17 and Local Planning Policy POL-LP-11 Variation to deemed-to-comply requirements of the R-codes - Medium-density single house development standards (R-MD Codes) for the R60 density code. The R-Codes do not apply where varied through POL-LP-11 and the provisions of this LDP.

Waste Management

- On laneway lots a bin pad (1.5m wide x 1.0m deep) shall be provided at nil setback from the laneway. Bin pad areas to be designated as per City of Swan requirements and fencing is not to obstruct the designated bin pad area.
