THE HALES FENCING PACKAGE - TERMS & CONDITIONS

This fencing package is subject to the Buyer completing the construction of a dwelling in accordance with the Restrictive Covenants, Development Conditions, Building Guidelines and Terms and Conditions of Sales Contract within twenty-four months (24) for either a single-storey or two-storey dwelling from date of settlement.

The Hales Fencing Package includes the following:

- Colorbond[®] fencing to the side and rear boundaries of your lot in accordance with The Hales Design Guidelines - Colour: Colorbond[®] Riversand. NOTE: The Hales Fencing Package does not include fencing of the front boundary of your lot or fencing or gates between the dwelling and side boundaries.
- 2. Where there is a retaining wall separating two lots that have a different pad level, the retaining wall is constructed wholly within the boundary of the "higher" lot. The outer face of the retaining wall is on the boundary. The Colorbond[®] will be erected in the middle of the retaining wall. That is to say, on the "higher" lot.
- 3. The developer will nominate the installer that is to provide and install The Hales Fencing Package to your home.
- 4. The Hales Fencing Package must be installed in your home within twenty-four (24) months of the settlement date of your lot.
- 5. This voucher is not transferable or assignable to any other party and may only be claimed by the buyer named in the Contract.
- 6. If The Hales Fencing Package is not claimed or redeemed within twenty-four (24) months of the settlement date of your lot, this voucher will expire worthless. The developer will have no further obligation or liability to provide or pay for The Hales Fencing Package.
- 7. The developer shall not be liable to you under any circumstances for the acts or omissions of the nominated installer responsible for the installation of The Hales Fencing Package in your home, including for any delay in completing the installation which may invalidate this voucher.
- 8. The development must be constructed to the land level identified within the Contract of Sale. Should the development be constructed at a differing level, the developer will have no further obligation or liability to provide or pay for the works identified within this package.
