1. A copy of agreement to install the Photovoltaic Cells with a minimum of 1.5kW;
2. A copy of the licensed electrician’s certificate of connection;
3. A copy of the practical completion certificate from your builder; and
4. A copy of the invoice from the installation company displaying amount paid in full.

Subject to the Buyer/s satisfying the Terms & Conditions in the Contract of Sale for the lot, the \$2,000 Solar Panel Rebate will be paid in accordance with the Terms & Conditions of the Contract to the Buyer's nominated bank account.

SOLAR PANEL REBATE TERMS AND CONDITIONS

1. Should the Buyer fail to complete their dwelling within **the contractually agreed period after settlement**, this offer will lapse and shall not be binding.
2. To qualify for the rebate, the Buyer is required to provide:
 - A copy of agreement to install the Photovoltaic Cells with a minimum of 1.5kW;
 - A copy of the licensed electrician's certificate of connection;
 - A copy of the practical completion certificate from your builder; and
 - A copy of the invoice from the installation company displaying amount paid in full.
3. Should the Buyer fail to submit this application form with all pertinent information within 12 months of practical completion date, this rebate will expire.
4. A site check will be carried out to ensure that the completed dwelling complies with the design guidelines prior to the payment of \$2,000 (incl. GST).
5. The package is not redeemable for cash or any other product or services. This offer is not transferable to a third party and will become null and void should the property be on-sold to another party.
6. By completing and lodging this form, the Buyer/s agrees that the rebate is to be transferred to the nominated bank account, even if the bank account is not in the joint names of the Buyers.
