



PHOTOVOLTAIC SOLAR SYSTEM REBATE APPLICATION FORM

THIS FORM FOR USE BY BUYERS IN CATALINA GREEN STAGE 39 ONWARDS ONLY

This solar package is conditional upon dwelling construction being completed within the contractually agreed period after settlement of the land. The following documents must be submitted with this application form:

1. A copy of the agreement to install a Photovoltaic Solar System with a minimum of 3.0kW converter.
 - a. If including integrated battery storage, this must be included in the agreement.
2. A copy of the licensed electrician's certificate of connection;
3. A copy of the practical completion certificate from your builder; and
4. A copy of the invoice from the installation company displaying amount paid in full.

Subject to the Buyer complying with Clause 1 in the Contract of Sale for the lot, the Seller agrees to pay to the Buyer the sum of up to \$4,000 as a Solar Panel Rebate to the Buyer's nominated bank account. The rebate will be increased by up to \$1,000 if the system also includes integrated battery storage. The Photovoltaic Solar System must be installed prior to lodgement of the solar rebate application form. **A full list of the Terms and Conditions is detailed below and must be read prior to submitting this application form.**

SOLAR PANEL REBATE TERMS AND CONDITIONS - STAGE 39 ONWARDS

1. Should the Buyer fail to complete their dwelling within **the contractually agreed period after settlement**, this offer will lapse and shall not be binding.
2. To qualify for the rebate, the Buyer is required to provide:
 - A copy of agreement to install the Photovoltaic Solar System with a minimum of 3.0kW by a licensed electrical contractor. If including integrated battery storage, this must be included in the agreement.
 - A copy of the licensed electrician's certificate of connection;
 - A copy of the practical completion certificate from your builder; and
 - A copy of the invoice from the installation company displaying amount paid in full.
3. Should the Buyer fail to submit this application form with all pertinent information within 12 months of practical completion date, this rebate will expire.
4. A site check will be carried out to ensure that the completed dwelling complies with the Design Guidelines prior to the payment of \$4,000 (including GST).
5. The Photovoltaic Solar System must be installed prior to lodgement of the solar rebate application form.
6. The package is not redeemable for cash or any other product or services. This offer is not transferable to a third party and will become null and void should the property be on-sold to another party.
7. By completing and lodging this form, the Buyer/s agrees that the rebate is to be transferred to the nominated bank account, even if the bank account is not in the joint names of the Buyers.
